A. ACTION ON ORDINANCE 27-2018-REZONE PROPERTY AT 2250 W 1800 S- FROM A-2 TO MIXED USE Chase with Ivory Development attended.

A neighborhood meeting was held, working with the neighbors and getting feedback on the proposed development. They created large lots as a buffer from the existing homes.

Councilmember Carlson expressed that she appreciates them working with the neighbors and listening to their needs. Councilmember Carlson asked if the roads would all be city owned with the exception of the 2 roads in the townhomes.

Chase expressed that, that was correct. The townhomes will be for sale and be owned units. Ivory plans to be the exclusive builder of the project.

A total of 4 cars will be available to park at the homes (2 in the garage and 2 on the driveway).

Councilmember Hunter asked if the primary objective of asking for Mixed Use to satisfy the density. Chase expressed yes, they are only building on about half of the entire project. The overall density is approx. 3.62 units per acre.
